MINIMUM FINANCIAL QUALIFICATIONS

We are looking for franchisees who have the passion and experience to deliver excellent guest experiences, build strong teams, meet the operational and financial requirements and take pride in growing the Bonchon brand.

Financial Requirements

Single Unit or Limited Development (1–2 Restaurants)

Minimum Liquid Capital: \$250,000 to \$400,000
Minimum Net Worth: \$750,000 to \$1,500,000

Large-Scale Development (5 or More Restaurants)

Minimum Liquid Capital: \$1,200,000 to \$2,000,000 or more
Minimum Net Worth: \$5,000,000 to \$10,000,000 or more

Multi-Unit Development (3–5 Restaurants)

Minimum Liquid Capital: \$750,000 to \$1,200,000
Minimum Net Worth: \$2,000,000 to \$5,000,000
